Three Additional Features!

- ◆ A suit demanding non-monetary relief (up to \$35,000 for defense costs).
- ◆ Sexual abuse; provided you are found not guilty or the charges are dismissed (\$35,000 annual maximum).
- ◆ Criminal charges arising out of corporal punishment; provided you are found not guilty or the charges are dismissed (\$10,000 annual maximum).

Who's Eligible?

Any member of one of our sponsoring educational associations who is a student preparing for employment, and performs educational duties under the supervision of a licensed educator.

What's My Coverage Amount?

You may receive \$1 million per occurrence in protection. Defense costs are paid in addition to this amount!

When Does My Coverage Apply?

Your plan will provide coverage for claims brought at any time, as long as the occurrence that resulted in litigation occurred while your Student Teachers Professional Liability policy was in effect. You'll be covered even if you've dropped the coverage — so long as your coverage was in force when the incident happened.
